- ❖ Stallholders must provide own marquees and tables.
- ❖ All persons will adhere to any **GOVERNMENT HEAT RULES** applying at Show Time.

- ❖ Abuse or threatening behaviour of any nature will not be TOLERATED.
- ❖ Non-For-Profit stalls FREE.
- ❖ **Friday Arrival** – available from 8am to 5pm NO EXTRA CHARGE.  
**PLEASE CONTACT SHOW OFFICE FOR AFTER HOURS ENTRY APPROVAL.**
- ❖ **Saturday Arrival** – Site stall and vehicles must be set up and parked by 7:30am
- ❖ **Traders** – **MUST** operate between 9am until close on Show Days.
- ❖ The committee reserve the discretionary right to refuse entry to any site holder without reason.
- ❖ Stallholders – must provide own public liability insurance and a copy **MUST** be sent with application.
- ❖ Stallholders – who bring electrical equipment for use on the grounds **MUST** display current test and tags on all leads.
- ❖ It is the responsibility of all stallholders to comply with the current WH&S Act together with all State and Local Government regulations.
- ❖ **THIS IS A SMOKING FREE VENUE.**
- ❖ Non-compliance or late cancellations will not receive a refund except at the discretion of the committee.
- ❖ **SPEED LIMIT WITHIN THE GROUNDS 10KM/H.**
- ❖ **NO VEHICLE MOVEMENT WITHIN THE GROUNDS BETWEEN 7:30AM AND 8:00PM ON SATURDAY 7:30AM AND 7PM SUNDAY.**
- ❖ Parking of vehicles with stalls **MUST** be approved by Trade Site Co-Ordinator.
- ❖ Stallholders' animals **MUST** remain on a leash and under control at all times.
- ❖ Sites will be allocated by Trade Site Co-Ordinator on arrival to the Showgrounds.
